

GSI GENERAL TERMS & CONDITIONS FOR INTERIOR DECALS, PLACARDS, PRINTING ETC...

- 1. THIS IS A FORMAL QUOTE THAT INVOLVES INTERIOR DECALS, PLACARDS, AND PRINTING ETC...
- 2. LEAD TIMES 10-12 BUSINESS DAYS UPON ART WORK/PROOF APPROVAL.
- 3. GSI RESERVES THE RIGHT TO SHIP 10% OVER OR UNDER ACTUAL QUANTITY ORDERED.
- 4. ALL PARTS SUBJECT TO AN INDUSTRY STANDARD +/- .010 .015 TOLERANCE.
- 5. DESIGN, TEXT, COLORS, SHAPES, AND FORMATS ARE TO BE DETERMINED AND APPROVED THROUGH ART WORK/PROOF PROCESS.
- 6. ALL ESTIMATED FLOW AND LEAD TIME IS SUBJECT TO CHANGE DEPENDING ON CHANGES IN CUSTOMER REQUIREMENTS AND/OR WORK LOAD AT TIME OF ORDER.
- 7. MINIMUM ORDER IS \$200.00.
- 8. EXPEDITE FEES WILL BE CHARGED: PER PART #, PER REQUESTED EXPEDITED DELIVERY DATE THAT FALLS OUTSIDE OF STANDARD LEAD TIME.
- 9. PLEASE STATE ON PURCHASE ORDER THAT: EARLY SHIPPING IS ACCEPTED FOR ALL ORDERS WITHOUT PENALITY OR CHARGES TO GSI.
- 10. CUSTOMER AGREES TO FURNISH SHIPPING ACCOUNT INFORMATION AND INSTRUCTIONS AT TIME OF PURCHASE, OTHERWISE CUSTOMER AGREES TO BE INVOICED FOR ALL SHIPPING CHARGES INCURRED BY GSI AFTER SHIPMENT.
- 11. TERMS FOR U.S. CUSTOMERS WOULD BE 1% DISCOUNT 10, NET 30 WITH APPROVED CREDIT APPLICATION. ALL OTHER ORDERS ARE CONSIDERED CASH/CREDIT ACCOUNTS AT TIME OF PURCHASE. CREDIT CARDS WILL BE CHARGED A 5% PROCESSING FEE. COD PAYMENTS WILL ALSO BE CHARGED ANY PROCESSING FEES DETERMINED BY REQUESTED CARRIER.



- 12. TERMS FOR NON U.S. CUSTOMERS: PAYMENT MUST BE MADE PRIOR TO SHIPMENT FOR ALL LINES ON THE CUSTOMER FIRST PO/SO VIA CREDIT CARD. THE PAYMENT WILL INCLUDE A 5% CREDIT CARD PROCESSING FEE AND BE MADE PRIOR TO SHIPMENT DUE
- 13. DATE. FURTHER FINACIALS TERMS CAN THEN BE ESTABLISHED TO 1% DISCOUNT 10, NET 30 WITH APPROVED CREDIT APPLICATION AND COMPLETED PROCESS.
- 14. ALL PAYMENT TERMS ARE IN U.S. DOLLARS (\$).
- 15. NON U.S. CUSTOMERS AND/OR CUSTOMERS REQUIRING SHIPMENT DELIVERY OUTSIDE THE UNITED STATES ARE RESPONSIBLE FOR ALL EXPORT/IMPORT FEES, TAXES, REQUIRED INSURANCES, AND MUST PROVIDE ALL NECESSARY EXPORT DOCUMENTATION OR CERTIFICATION INFORMATION PRIOR TO SHIPMENT IN WRITING TO GSI.
- 16. QUANTITIES GREATER THAN ORIGINAL QUOTE WOULD REQUIRE ADDITIONAL PRODUCTION TIME AND COST. PRICE BREAKS WOULD BE ISSUED AT THAT TIME ONLY.
- 17. QUOTE IS VALID FOR 30 DAYS FROM ISSUE.
- 18. C OF C IS PROVIDED WITH ORDER.
- 19. GSI RESERVES THE RIGHT TO UPDATE, MODIFY, OR OTHERWISE CHANGE ANY OR ALL TERMS & CONDITIONS AS NECESSARY WITHOUT PRIOR WRITTEN NOTIFICATION TO CUSTOMER.
- 20. CUSTOMER ACKNOWLEDGES THAT ACCEPTANCE BY GSI OF ANY PURCHASE ORDER ALSO CONSTITUTES CUSTOMER'S AGREEMENT TO GSI TERMS & CONDITIONS.
